## TERMS AND CONDITIONS

### 1. EDUCATIONAL MATERIALS AVAILABLE FROM CEPC.

Chicago Educational Publishing Company, LLC ("CEPC") will provide Educational Materials under the following terms (the "Agreement"). "Educational Materials" means one or more copies of the following items: (a) curriculum and supporting materials, electronically ("Digital Editions"), (b) manuals, books, booklets, cards and other printed materials provided to Customer ("Printed Materials"), and (c) ExploraGear® science materials and other consumables and replacement items ("Kits"). Notwithstanding the foregoing, if there is a conflict between the terms of this Agreement and the terms of the applicable website promoting the Educational Materials, including but not limited to [www.sciencecompanion.com](http://www.sciencecompanion.com) ("Website"), or other materials provided by or on behalf of CEPC to Customer with respect to Educational Materials, the applicable Website or such other materials provided by or for CEPC shall control over the terms of this Agreement.

### 2. PRINTED MATERIALS; DIGITAL EDITIONS.

Printed Materials are sold to Customer, subject to CEPC's reservation of rights as set forth in Paragraph 6 below. Educational Materials other than Printed Materials and Kits are provided to Customer for its use under a license agreement ("License"). The terms of the applicable license can be reviewed on the applicable Website.

### 3. PAYMENTS; SHIPMENT.

Unless otherwise specified, all payments due CEPC with respect to Educational Materials shall be due no later than thirty (30) days after the date such Educational Materials are provided or shipped to Customer. Customer's right to possess and use Educational Materials, and all of its other rights hereunder, are expressly contingent and dependent upon timely and full payment of the applicable amounts. A service charge at the rate of one and one-half percent (1-1/2%) per month (18% per annum) or, if less, the maximum rate permitted by law will be added to all past due accounts until paid in full.

CEPC will endeavor to ship Educational Materials promptly after receipt, acceptance and processing of orders, subject to availability. CEPC may determine the method of shipment in its discretion. All returns of Educational Materials, for whatever reason, must be returned, pre-paid and insured, via a reputable, national and traceable carrier, or via such other method as CEPC may specify. Educational Materials shall be returned in the containers in which they were received from CEPC. Customer shall pay all shipping and handling charges for all deliveries, returns or other transport of Educational Materials. The Customer shall also pay additional charges for expedited shipment requested by Customer and agreed to by CEPC.

### 4. RESTRICTIONS ON USE.

Customer shall not, and shall ensure that all others do not, directly or indirectly: copy, reproduce, disassemble, reverse engineer, attempt to repair or in any way tamper with any Educational Materials; sell, rent, lease, sublicense, lend, transfer, assign, encumber, hypothecate or in any way part with or share possession of any Educational Materials for any period of time, modify, edit, add to, make works derived from or in any manner alter any Educational Materials, charge any fee or other consideration in connection with any exhibition or other use of any Educational Materials; advertise or otherwise publicize any exhibition or use of any Educational Materials except internally and to Customers' employees to whom Educational materials may properly be exhibited hereunder; send, export, re-export, exhibit or otherwise use the Educational Materials anywhere outside of the country in which Customer takes delivery, or cause or permit any exhibition, display, performance, duplication, distribution, adaptation, transmission, re-transmission, broadcast (including without limitation, via closed circuit, pay cable or subscription television service) or other use of the Educational Materials, except as specifically authorized by this Agreement or otherwise by written permission of CEPC or its licensors.

### 5. WARRANTY, DISCLAIMER AND LIMITATIONS OF REMEDY AND LIABILITY.

CEPC warrants to Customer, for all Digital Editions ordered by Customer, that those Digital Editions' physical media, if any, will be without material defect in materials or workmanship when received by Customer from CEPC. Furthermore, all Educational Materials shall comply in all materials respects with the description of such materials in the applicable CEPC curriculum descriptions. THE FOREGOING WARRANTY IS IN LIEU OF AND EXCLUDES ALL OTHER WARRANTIES, EXPRESS OR IMPLIED BY OPERATION OF LAW OR OTHERWISE, INCLUDING BUT NOT LIMITED TO ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE OR WARRANTIES AGAINST INTERFERENCE OR AGAINST CLAIMS OR INTERESTS OF THIRD PARTIES OR WARRANTIES AGAINST INFRINGEMENT. CEPC' warranty liability in any case is limited to, at CEPC' election, (a) repair or replacement (in the form originally shipped) of Educational Materials not complying with the foregoing warranty, or (b) cancellation of this Agreement with respect to non-complying Educational Materials and repayment of, or crediting Customer with, the associated amounts paid by Customer, provided, however, that Customer give CEPC immediate notice, in writing, of the date and time of receipt of the non-complying Educational Materials and the nature and extent of any defects, and immediately return the non-complying Educational Materials in accordance with the provisions of this Agreement. IN NO EVENT SHALL CEPC OR ITS EMPLOYEES, AGENTS, LICENSORS OR CONTRACTORS BE LIABLE FOR ANY DIRECT, INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL, PUNITIVE OR EXEMPLARY DAMAGES, DAMAGES FOR LOSS OF PROFITS, GOODWILL, USE OF DATA OR OTHER INTANGIBLE LOSSES (EVEN IF CEPC OR AN AUTHORIZED CEPC REPRESENTATIVE HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES), RESULTING FROM: (i) THE LOSS OF DATA AND/OR THE USE OR THE INABILITY TO USE ANY OF THE EDUCATIONAL MATERIALS; (ii) THE COST OF PROCUREMENT OF SUBSTITUTE GOODS AND SERVICES RESULTING FROM ANY GOODS, DATA, INFORMATION OR SERVICES PURCHASED OR OBTAINED OR MESSAGES RECEIVED OR TRANSACTIONS ENTERED INTO THROUGH OR FROM ANY OF THE EDUCATIONAL MATERIALS; (iii) UNAUTHORIZED ACCESS TO OR ALTERATION OF YOUR TRANSMISSIONS OR DATA; (iv) STATEMENTS OR CONDUCT OF ANY THIRD PARTY IN OR WITH RESPECT TO ANY OF THE EDUCATIONAL MATERIALS, OR (v) ANY OTHER MATTER RELATING TO THE EDUCATIONAL MATERIALS, WHETHER SUCH CLAIM IS BASED UPON BREACH OF CONTRACT, BREACH OF WARRANTY, NEGLIGENCE, STRICT LIABILITY IN TORT OR ANY OTHER THEORY OF RELIEF.

### 6. COPYRIGHT AND LICENSE.

All Educational Materials other than Kits are protected by copyright and are owned exclusively by CEPC or its licensors, and any use, exhibition, duplication, distribution, performance, derivation or adaptation of such Educational Materials other than as specifically authorized by this Agreement is prohibited. Except as specifically provided to the contrary in this Agreement, Customer obtains no ownership of Educational Materials, other than Kits. All rights not expressly granted Customer under this Agreement are reserved to CEPC and its licensors.

### 7. CANCELLATION.

No attempted revocation or cancellation of any order by the Customer shall be effective unless in writing and received by CEPC at least one (1) business day prior to shipment. Any effort by Customer to change (a) the location to which the Educational Materials are to be delivered, or (b) the particular Educational Materials ordered shall, without limitation, be deemed an attempted "cancellation." In the event any Educational Materials are discontinued or temporarily out of stock, CEPC shall so notify the Customer and shall, at the Customer's option, cancel the order and refund any applicable amounts that may have been paid by the Customer, substitute other Educational Materials of equivalent price and terms, or reschedule the Customer's order. CEPC' liability for discontinuations, back-orders or similar circumstances shall be limited to the foregoing options and shall be further limited as provided elsewhere in this Agreement.

### 8. ORDERS.

CEPC ACCEPTS ORDERS FOR EDUCATIONAL MATERIALS ONLY ON THE EXPRESS CONDITION THAT CUSTOMER ASSENTS TO ALL OF THE TERMS OF THIS AGREEMENT, INCLUDING WARRANTY, DISCLAIMERS AND LIMITATION OF REMEDY AND LIABILITY, AND NO OTHERS. NO PRE-PRINTED OR OTHER SUCH TERMS AND CONDITIONS, WHETHER MATERIAL OR OTHERWISE, CONTAINED IN ANY PURCHASE ORDER OR OTHER WRITING OR FORM OF CUSTOMER SHALL BE OF ANY FORCE OR EFFECT, AND CEPC HEREBY NOTIFIES CUSTOMER OF ITS OBJECTION TO ALL SUCH TERMS AND CONDITIONS.

### 9. INDEMNIFICATION.

Customer agrees to indemnify and hold CEPC and its subsidiaries, affiliates, officers, agents, directors, licensors, contractors and employees harmless from any claims, actions, costs, liabilities, expenses and damages, including reasonable attorneys' fees and expenses, made against CEPC or any such CEPC party by any third party due to or arising out of Customer's use of any of the Educational Materials or Customer's breach of any provision of this Agreement.

### 10. GOVERNING LAW AND JURISDICTION.

This Agreement and all of the parties' rights and obligations hereunder shall be governed by the laws of the State of Illinois (excluding conflicts rules) and of the United States. Customer hereby consents to jurisdiction and venue in the federal and state courts located in Cook County, Illinois for purposes of this Agreement and its subject matter. Any suit or proceeding in connection with this Agreement or its subject matter and commenced by Customer shall be commenced and maintained only in such courts.

### 11. GENERAL.

Other than the terms of this Agreement, which are binding on the parties, any terms and conditions that are typed or printed on the reverse of or otherwise included in or to any Customer request for quotation or bid, purchase order, acceptance, confirmation or other purchase document will be deemed to be solely for the convenience of the parties. No such term or condition will be binding upon either party, and no action by either party (including, without limitation, the issuance of a purchase order or an acceptance in whole or in part or acceptance of the order) will be construed as binding such party with respect to any such term or condition, unless the specific term or condition has been previously agreed to by CEPC and Customer in writing, and is binding upon such party with respect to such purchase order or acceptance invoice by virtue of this Agreement or a binding amendment thereto.

Customer is responsible for and CEPC may invoice Customer for any and all federal, state and local taxes, duties, tariffs or import fees whatsoever in connection with any transactions with Customer under this Agreement. All notices required or permitted hereunder shall be sent by telegram, telex, overnight courier service or by certified or registered mail (return receipt requested) directed to Customer or CEPC, as applicable, at their respective business addresses set forth in CEPC' invoice. Customer shall pay CEPC' reasonable attorneys' fees and other expenses incurred in enforcing any of its rights under this Agreement.

CEPC shall not be in breach of this Agreement, and shall have no liability, for any failure of or delay in performance under this Agreement by reason of war, riot, civil disturbance, fire, explosion, flood, act of nature, strikes, lockouts, labor disputes, burglary, malicious damage, weather conditions, transport failure, traffic congestion, failures or delays of suppliers, carriers or other third parties, any acts of any governmental instrumentality or agency, or any cause whatsoever beyond CEPC' control.

The entire agreement between CEPC and Customer is contained exclusively in this Agreement. CEPC shall not be liable for any act or obligation other than those herein expressly required of it, whether or not any oral or written representation to the contrary is made by any person, either before or at the time this Agreement is made. This Agreement may not be modified except by a written amendment signed by both Customer and CEPC. If any provision of this Agreement shall be deemed invalid or unenforceable by any court or governmental agency, such provision shall be deemed removed from this Agreement and replaced by a valid provision that serves the intent of the parties to the maximum extent permitted by law.
